The National RPAC portion is used to support federal candidates and is charged against your limits under 52 U.S.C. 30116.

The Real Estate Community Political Action Committee (RECPAC) is a group of local REALTORS® focused on local (city/county) real estate political issues and candidates in central New Mexico. A RECPAC voluntary contribution of \$25.00 is strongly encouraged to support and inform local pro REALTOR® candidates and educate the public on legislative issues affecting the local real estate market and community. Tax Information:

Non-Deductible Dues: Dues and assessments are not deductible as charitable contributions for federal income tax purposes (Compliance with the Tax Reform Act of 1993). Such payments may be deductible as ordinary and necessary business expenses. The portion of dues and assessments attributable to lobbying will not, however, be deductible. For 2018, the amounts that are attributable to lobbying (non-deductible part) are: **NAR Dues: \$52.00 and RANM Dues: \$42.00.**

Deductible Fee: Your 2018 dues include a \$35.00 mandatory assessment by the National Association of REALTORS® of all REALTOR® and Institute Affiliate members to fund a nationwide public awareness campaign that includes TV network and cable ads highlighting the value a REALTOR® brings to a transaction and stressing the importance of using a REALTOR®. The campaign and the assessment will run through the year 2018. The entire \$35.00 portion of NAR's Public Awareness Campaign qualifies as deductible dues.
